## **AGREED ORDER**

This day came the defendants, Monsanto Company, et al., by their undersigned counsel and came the Court-appointed Class Administrator, Thomas V. Flaherty d/b/a Nitro Class Action Settlement Administrators, LLC, and jointly announced to the Court that the defendants and the Class Claims Administrator have agreed upon the compensation to be paid to the Class Claims Administrator for calendar year 2019. Specifically, the parties have agreed that the compensation to be paid to the Class Administrator for services rendered in administering the medical monitoring program during calendar year 2019 shall be reasonable and necessarily incurred expenses plus the aggregate sum of One Hundred Fifty Thousand Dollars (\$150,000.00). Whereupon, the undersigned jointly moved the Court to approve such compensation be paid out of the established escrow account for the medical monitoring program.

After mature consideration of such motion and for good cause shown, the Court is of the opinion to, and does hereby **GRANT** such motion.

Accordingly, it is hereby **ORDERED** that the aforesaid Class Administrator be compensated in the aggregate sum of One Hundred Fifty Thousand Dollars (\$150,000.00) plus reasonable and necessary expenses for services rendered administering the medical monitoring program benefits during calendar year 2019. The Court further directs that said sum be paid

from the escrow account established and funded by the defendants for the medical monitoring program.
